"Town Hall Meeting on Costs of the Iraq War"

On Tuesday, November 1, the Sacramento City Council voted 8-1 in support of a Resolution to withdraw U.S. troops and bases from Iraq. Six days earlier, a "Media Edge" crew was on hand to record a "Town Hall Meeting on Costs of the Iraq War" at Sacramento's Coloma Community Center. Agreeing that this was an important event that residents should see before the City Council meeting where the Resolution would be considered, Access Sacramento pre-empted its normal schedule to show the "Media Edge" coverage of the Town Hall meeting on Sunday evening, October 30.

Featured speakers at this Town Hall included former Sacramento Mayor Anne Rudin, Hugo Vera of the Mexican American Political Association, CSU-Sacramento Sociology professor Dr. Ayad Alqazazz, Ruth Holbrook of the Central Labor Council, David Main of Veterans for Peace, and Jeanette Madison of Military Families Speaking Out. Sacramento City Council member Kevin McCarty also attended this event.

The purpose of the Town Hall meeting was to inform the large audience about how the Iraq War impacts our communities back here at home, and to encourage residents to get involved in these matters on the local level. We were very pleased to see that over 100 residents attended the November 1 City Council meeting to show their support for the Resolution, which was adopted by the Council with only one member opposed.

A film that brings alive the history of the struggle for women's reproductive rights in the United States and the chilling facts about the current threats to those rights. Intimate interviews reveal the passion of people who moved abortion from the danger of the back alleys to a safe, legal choice.

Episode #3 (April 17-18)

Segment #1. "Hijacking Catastrophe: 9/11, Fear & the Selling of American Empire"

This powerful documentary examines how a radical fringe of the Republican Party used the trauma of the 9/11 terror attacks to advance a pre-existing agenda to radically transform American foreign policy while rolling back civil liberties and social programs at home.

Segment #2. "Losing Hearts and Minds"

The US has lost moral authority in Iraq, with abuses continuing even since the Abu Ghraib scandal first came to light. Featuring footage shot on the ground in Iraq.

Segment #3. "National Insecurities" (from Deep Dish TV's "Shocking and Awful" series)

Violence against immigrants, especially Arabs; imprisonment without trial, especially for Muslims. Is the U.S. government fomenting fear to inflame racial and ethnic divisions? History repeats itself, as violence against immigrants and imprisonment without trial become routine.

Episode #2 (April 10-11)

Segment #1. "A Quiet Neighborhood"

A closer look at the anti-Bush display and reactions to it at the Sacramento Land Park home of Virginia and Stephen Percy.

Segment #2. "The Real Face of the Occupation" (from Deep Dish TV's "Shocking and Awful" series)

How U.S. military occupation looks from the other end of the gun barrel. Was Abu Ghraib an exception or merely an extreme? How has Iraq changed since the fall of Saddam? What is life like under occupation? On-the-ground footage shows the humiliation and dehumanization inevitable in a colonial situation.

Segment #3. "Uncovered: The Whole Truth about the Iraq War"

This documentary chronicles the Bush Administration's determined quest to invade Iraq following the events of September 11, 2001. The film deconstructs the administration's case for war through interviews with U.S. intelligence and defense officials, foreign service experts, and U.N. weapons inspectors. Their analyses and conclusions are sobering, and often disturbing, regardless of one's political affiliations.

Episode #1 (April 3-4)

Segment #1. "An Eyewitness to the War in Iraq: An Hour with Dahr Jamail"

Through journal entries and slides from his 8 months in occupied Iraq, US journalist Dahr Jamail's talk with Denis Bernstein of KPFA puts a face on the people of that war-torn country. Taped on February 25, 2005 in Oakland.

Segment #2. "Globalization at Gunpoint: The Economics of Occupation" (from Deep Dish TV's "Shocking and Awful" series)

The military occupation of Iraq has enabled the U.S. to enforce privatization of the Iraqi economy, in effect, selling off Iraq's assets to foreign investors. A look at the challenges to privatization.

Segment #3. "Saddam Hussein was not a Threat to the U.S."

Scott Ritter, former lead U.N. weapons inspector in Iraq, argues that Bush Administration officials knew Saddam Hussein posed no threat to the United States, even as they justified war on grounds of self-defense.
